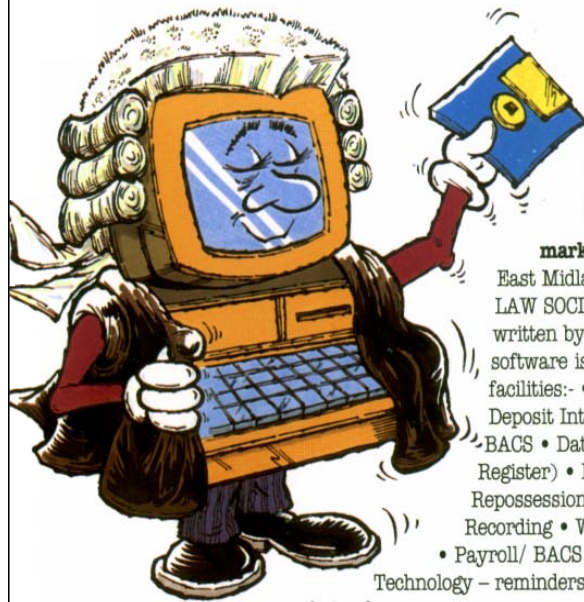


GASE HISTORY
